Summary: Apologies for the EoP culture inaccurate interpretation that Donald Trump's peace talk may have been – reach for the EoP sanity mop – sincere. Confirmation of Donald Trump's fully informed consent cultural membership status as conscious and intentional Babylonian. I am hereby notifying you of my withdrawal of Ecology of Peace culture objections to the mental disorder allegations leveled against your client: Donald Trump by Duty to Warn Psychiatrists.

In the context of EoP Culture Honesty Test, based on Luten Conservation Sanity Test; both Donald Trump [20 Jun: [EoP LJvLS Offer for Pres Trump: If Trump wants EoP honesty USvIR negotiations](#)] and Duty to Warn Psychiatrists [22 May: [LJ v LS Req for Info: Duty to Warn Psych](#)] fail to the pass the EoP Culture Honesty – reach for the mop sanity – Test.

Ecology of Peace Functional Interpretation of Objective Reality Transforming the World
Constraints for Sincere Peacenik / Honourable Warrior Individuals, Organizations, Races, Religions, Classes, Genders, Ideologies:

Ecology of Peace Radical Honoursty Factual Reality [eop-rh-fr.tygae.org.za] and EoP Scientific and Cultural Law [eop-scicultlaw.tygae.org.za] are EoP culture's functional group shared system of thought and action frame of orientation and object of inter-species relating devotion interpretation of reality for individuals whose object of devotion/values include: (i) honest – race, religious, gender and cultural – relationships; (ii) an ecological carrying capacity based perspective of observable factual social contract reality; and (iii) non-violent cooperative root cause problem solving.

Sincere Peacenik / Honourable Warrior: Interpretative Reality:

Based upon my observations of Donald Trump's absolute total lack of actions towards reaching for the EoP mop to cooperate to authorize EoP UN Resolution [[lj-v-ls: PDF pp.25-66/70](#)] to implement EoP Scientific and Cultural law as international law, and preponderance of actions towards reaching for the WiP faucet I no longer have any benefit of the doubt left that Donald Trump's 'peace talk' is – reach for the mop sanity – sincere.
